Health Reform to Require Insurers to Use Plain Language in Describing Health Plan Benefits, Coverage

People in the market for health insurance will soon have clear, understandable and straightforward information on what health plans will cover, what limitations or conditions will apply, and what they will pay for services thanks to the Affordable Care Act – the health reform law – according to final regulations published last week.

The marketing materials that insurers use can sometimes make it difficult for consumers to understand exactly what they are buying. The new rules, published jointly by the Departments of Health and Human Services, Labor and Treasury, require health insurers and group health plans to provide concise and comprehensible information about health plan benefits and coverage to the millions of Americans with private health coverage. The new rules will also make it easier for people and employers to directly compare one plan to another.

Funding Opportunity

Veterans Transportation and Community Living Initiative Grants

For the second round of the Veterans Transportation and Community Living Initiative (VTCLI) grant program, the Federal Transit Administration (FTA) is making \$25 million of Section 5309 Bus and Bus Facilities funds, as well as approximately \$5 million of Section 5312 Research Program funds available. FY 2012 VTCLI grants can consist of two separate awards.

Each applicant may request up to \$2 million in 5309 funds for One-Call/One-Click Transportation Resource Center capital costs and Up to \$50,000 in 5312 funds for support costs such as marketing, outreach and coordinated planning to demonstrate the successful implementation of a One-Call/One-Click Center. Requests for S5312 funding will not be considered without a S5309 capital project proposal.

The application deadline is 11:59pm April 19, 2012.

The US Environmental Protection Agency (EPA) invites the public to submit creative projects to the 6th annual Rachel Carson Intergenerational “Sense of Wonder” Contest. There are four categories: photography, essay, poetry, and dance. This year, in honor of the 40th anniversary of the Clean Water Act, the contest will focus on a “Sense of Water.”

Contest submissions are encouraged to focus on the various properties of water – how it tastes, what it sounds like, how it feels, – and what water means to the entrants.

Carson is considered to be the founder of the contemporary environmental movement through her landmark book, “Silent Spring.” The contest seeks to spur and instill the same sense of wonder Carson had among all generations.
