New Resources Help Older Americans and People with Disabilities Maintain Their Independence

Seniors, people with disabilities and their families get assistance from local resource centers

Health and Human Services (HHS) Secretary Kathleen Sebelius last week announced \$12.5 million in awards to Aging and Disability Resource Centers (ADRCs) to support older Americans and people with disabilities stay independent and receive long-term services and supports.

These grants, funded by the Affordable Care Act and the Older Americans Act, support counselors who help individuals and their caregivers identify and access long-term services and supports, regardless of income or financial assets.

Two different types of grants were announced. Part A, for states or territories receiving an initial ADRC grant for an Enhanced ADRC Options Counseling Program and Part B, for states and territories receiving continuation funding.

Health Care Law Saved an Estimated \$2.1 Billion for Consumers

The health care law – the Affordable Care Act – has saved consumers an estimated \$2.1 billion on health insurance premiums according to a new report recently released today by the Department of Health and Human Services. For the first time ever, new rate review rules in the health care law prevent insurance companies in all states from raising rates with no accountability or transparency. To date, rate review has helped save an estimated \$1 billion for Americans. Additionally, the law's Medical Loss Ratio (or 80/20) rule is helping deliver rebates worth \$1.1 billion to nearly 13 million consumers.

Beginning Sept. 1, 2011, the health care law implemented federal rate review standards. These rules ensure that, in every state, insurance companies are required to publicly submit for review and justify their actions if they want to raise rates by 10 percent or more. To assist states in this effort, the Affordable Care Act provides states with Health Insurance Rate Review Grants to enhance their rate review programs and bring greater transparency to the process. 42 states have used their rate review grant funds to make the rate review process stronger and more transparent.

Veterans in Rural Areas to Get Expanded Access to Health Care

Department of Health and Human Services (HHS) Secretary Kathleen Sebelius and Secretary of Veterans Affairs (VA) Eric K. Shinseki last week announced a joint effort to expand health care delivery to veterans living in rural areas. The agreement between the two agencies promotes collaboration between VA facilities and private hospitals and clinics, and is supported by \$983,100 in grants to improve access and coordination of care through telehealth and health information exchanges in rural areas.

Three states with the highest density of veteran residents—Virginia, Montana and Alaska—will each receive approximately \$300,000 to implement or upgrade telehealth capabilities for veterans who must otherwise travel long distances to access medical, mental and behavioral health care. The grants will be used for telehealth equipment and to develop electronic health records that are compatible with the VA's Veterans Health Information Systems and Technology Architecture (VISTA) system.

Rural Health Network Development Planning Program

This funding opportunity solicits applications for the Rural Health Network Development Planning Grant Program (Network Planning). The purpose of the Network Planning Program is to promote the development of integrated healthcare networks in order to:

- achieve efficiencies,
- expand access to, coordinate, and improve the quality of essential health care services and
- Strengthen the rural health care system as a whole.

This program brings together key parts of a rural health care delivery system, particularly those entities that may not have collaborated in the past, to work together to establish or improve local capacity and coordination of care. The grant program supports one year of planning to develop and assist health care networks in becoming operational. These networks can include a wide range of

community partners including social service agencies, faith-based organizations, mental health agencies, charitable organizations, educational institutions, employers, local government agencies, or other entities with an interest in a community's health care system.

The application deadline is October 15, 2012.

They take responsibility for the quality of care they provide to people with Medicare in return for the opportunity to share in savings realized through high-quality, well-coordinated care. Community-based organizations can play an important role in this care coordination. In this webinar we will present an overview of ACO efforts to date, and spotlight a partnership developed between a Pioneer ACO and community-based providers in Massachusetts.

Justice Releases Report on Federal Agencies' Electronic and Information Technology (EIT) Accessible to People with Disabilities

Last week, the Justice Department released its report "[Section 508 Report to the President and Congress: Accessibility of Federal Electronic and Information Technology](#)." The report is authorized under Section 508 of the Rehabilitation Act of 1973.

Specifically, Section 508 requires federal agencies to ensure that electronic and information technology (EIT) they develop, procure, maintain, or use allows employees with disabilities and members of the public seeking information or services to have access to and use of information and data that is comparable to that available to people who do not have disabilities. EIT includes telecommunications products (such as telephones), information kiosks and transaction machines, websites, multimedia, and office equipment, such as copiers and fax machines, computers, software, firmware and similar products and services.

In 2010-2011, the Department created survey instruments and solicited answers from federal agencies about their implementation of Section 508. The survey requested data in four important areas: procurement, general processes for implementing Section 508, administrative complaints and civil actions, and website compliance.

While there is always room for continued improvement, The Administration for Community Living (ACL) is particularly pleased to note that the DOJ report commends the Department of Health and Human Services (HHS) for developing best practices in ensuring "Accessibility of EIT Used in Programs or Activities Receiving Federal Financial Assistance." The example DOJ commends is the Centers for Medicare and Medicaid Services' *Guidance for Exchange and Medicaid Information Technology (IT) Systems, Version 2.0*, requiring health insurance exchanges and Medicaid enrollment and eligibility systems to be accessible under Section 504, which reflected vital input from ACL and the HHS Office for Civil Rights.
